WHEREAS, the New York State Comptroller is authorized by sections 34 and 334 of the Retirement and Social Security Law to adopt rules and regulations for reporting the service and salary information for all employees of participating employers in the New York State and Local Employees' Retirement System, hereinafter referred to as "the Retirement System"; and

WHEREAS, the County is a participating employer in the Retirement System; and WHEREAS, the Comptroller has promulgated a regulation published at 2 NYCRR §315.4 which imposes certain reporting requirements on elected and appointed officials of participating employers who are members of the Retirement System and requires the governing body of each participating employer to adopt a resolution establishing a standard work day for each such elective or appointive office or position; and

WHEREAS, the County previously has established standard work days for all its employees who are members of collective bargaining units pursuant to collective bargaining agreements that have been approved by this Legislature; now, therefore, be it

RESOLVED, that the County hereby establishes the following as standard work days for elected and appointed officials who are members of the Retirement System for whom a Standard Work Day has not previously been established pursuant to a collective bargaining

agreement, and will report the following days worked to the Retirement System based on the record of activities maintained and filed by these officials with the Clerk of the Legislature:
